- i) The College login will be closed after the last date.

FEE STRUCTURE

The Prescribed Examination fee is Rs.1180 + Rs.60/- (Memo of Marks) + Examination Processing Fee is Rs.300/- (Once in a course time), i.e. Total fee of Rs.1540/-

Please do not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students. A Xerox copy of Medical Certificate confirming their status as Handicapped (Minimum percentage of disability must be of 40%) must be attached to the application forms. Blind, Physically Disabled, Deaf & Dumb students Application forms should be submitted along with separate Nominal Roll.

Xerox copies of Examination Application Forms & Photographs will not be considered.
