A Xerox copy of Medical certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb students Applications forms should be submitted separately along with Separate Nominal Roll.
